X. NOTICE

1978 Amendments to SOLAS relative to radio communications, commonly known as GMDSS, required a complete changeover to GMDSS by 1 February 1999 and also mandate the installation of a NAVITEX and a satellite EPIRB by August 1993.

Owners are reminded that the vessel ***MUST COMPLY*** with the provisions of these regulations no later than 1 February 1999 and that all vessels constructed on or after 1 February 1995 must comply on registration under the Vanuatu Flag.

NO EXEMPTIONS WILL BE GRANTED FOR FAILURE TO COMPLY WITH THESE REQUIREMENTS AFTER THOSE DATES.
